









WILLIAM (BILL) ARVEL CUMMINGS, JR. 21 JANUARY 1946 - 27 MARCH 2023

On April 11 I was notified by Craig Myers that Bill and Shirley Cummings have both passed away from medical issues.

Bill's brother in-law, Mike (Shirley Cummings half-brother), stopped in and informed Craig. He said it was about 2 weeks ago. Bill developed a brain bleed and was in the hospital and Shirley developed pneumonia and was staying with other family. Shirley then fell and broke her hip and was in the hospital at the time as well.

They both passed a week or so apart he said.

Mike said Bill was cremated at Springfield Memorial Gardens.

I subsequently contacted Springfield Memorial Gardens and was able to obtain the date that Bill passed away. I also asked them to relay to Bill's daughter, Diane Barnes, that I would like to speak with her about obtaining more information and Next-of-Kin information.

On April 26, I spoke with Diane Barnes (Bill's daughter) and was able to obtain more information. Service Arrangements are pending later for a combined service for William and Shirley Cummings – Diane will notify the Marine Corps League when details are finalized. This is tentatively being thought of for later in June and will be a memorial service. I also provided Diane with some information as to the benefits that William rated as a Marine Corps Veteran.

A combined Obituary for William & Shirley is also pending.

William and Shirley were both cremated, and their ashes will be spread in Hawaii. William had previously been stationed in Hawaii, and Shirley always wanted William to take her to Hawaii but he quit flying some time ago – but he told Shirley she would have to cremate him to get him to fly to Hawaii – so they are both going to Hawaii for their final resting place.

Bill was admitted to the hospital with a bleeding stroke. While he was there Shirley was staying with her daughter Diane. Shirley fell and broke her hip, so she was admitted to the hospital. While there Shirley had a heart attack. Shirley passed away in the hospital on 21 April 2023. Not knowing that Shirley had passed, William passed away 6 days later on 27 April 2023.

William Cummings was retired from the excavation business that he owned and operated.

Shirley Cummings was retired from her profession as a phlebotomist.

Bill was one of those Marines who stepped up and helped accomplish this monumental feat.







The first major part was to replace the driveway parking area and sidewalk to the front porch so a wheelchair could roll across it easily.

Bill utilized his excavation experience, skills, and equipment to accomplish the demolition, removal, and hauling away of all the old concrete.











THE BATTLE OF GETLIN'S CORNER

Getlin's Corner was extraordinary!
No other Marine battle of such short
durations resulted in as many of the
nation's 3 highest awards for valor: 6 Silver
Stars, 4 Navy Crosses, and the Medal of
Honor. It is named after Company
Commander Mike Getlin and the map
coordinates where the battle took place.

In the late afternoon of 30 March 1967, the 220 Marines of India Company were attacked by a 700-800-man battalion of the North Vietnamese Army (NVA). The battle lasted just six hours and included hand-to-hand combat, which was a rarity in the Vietnam War. The NVA's objective was the company command post which was breached numerous times. Finally, close to midnight and as the NVA were regrouping for a final assault, two Marine helicopters from VMO 2 broke the back of the enemy attack and forced the NVA battalion to withdraw from the battlefield.

<u>James (Jim) Pilling</u> – Jim had a follow-up with his urologist and then had surgery to remove tumors from his bladder. Jim is to undergo 6 weeks of chemotherapy. He went through this same type of cancer treatment about 1½ years ago. This is a recurrence and Jim told me that they were classifying his cancer as "aggressive." Jim is "Thinking Positive, and has his two daughters and families in his corner."

I told Jim, "If there is anything we (me or the League) can do for you please do not hesitate to let us know," and that I would let the members know what is going on.

Jim's chemotherapy is currently on-hold. Jim reports: "Prayers to Ray and family. My bladder cancer treatment has been placed on hold. Urologist cannot find enough of the drug for my 6-week chemotherapy treatments. Will bide my time and remain optimistic!"

Please keep Jim and his family in your thoughts and prayers as he traverses the path of cancer treatment.



<u>Ray Miller</u> – Ray was admitted to Riverbend Medical Center on Monday, 17 April 2023, as a precaution to prevent further injury. He underwent neurosurgery on Thursday morning. They were able to relieve the pinching of the spinal cord. As of Saturday, he was awaiting a Physical Therapy evaluation to determine if he could go home and have inpatient therapy or if he would go to inpatient (Boot Camp) physical therapy. It will be a long process to see how much hand/arm and leg use can be regained.

Steve & Lois Price visited with Ray on Friday. They reported that Ray was making improvements: the swelling in his hands had gone down drastically and he was getting feeling in his legs. Ray was up and sitting in a chair and felt like talking.

By Saturday Ray was able to close both hands into a gentle fist, and the swelling in his hands was mostly gone. He said that Friday night when the nurse was getting him into bed, he was able to feel that she was doing something with his feet (compression devices for his legs).

Ray has some new hardware in his upper vertebraes.

Nancy Lukasik talked to Linda who said he is in quite a bit of pain. They offered him Tylenol with oxycodone but he refused it. So, he's just taking Tylenol. He sees the nurse practitioner on Tuesday and starts physical therapy on Monday (it has just been a week.) She says he is a "tough old bird," and is doing okay."

Talked to Ray on 28 April 2023, he sounds good. They are waiting for some meds to be delivered. He starts Physical Therapy on Monday, followed by Occupational Therapy on a different day. Sounds like this will be a daily routine. He also has a surgery follow-up coming up.

Please keep Ray and Linda in your continued thoughts and prayers as they travel this long road of recovery.



<u>Nancy Lukasik</u> – Nancy was able to attend the April meeting. She is getting used to the pacemaker, and she looked good.



<u>Eddie Mosteller</u> – Eddie had surgery for his back, and during this surgery they think he may have suffered a stroke (experiencing some symptoms like stroke). Jeanne will let us know more later when they make a diagnosis. More testing to take place.



<u>Kim Lonberg</u> – Kim was at the April meeting and reported that she is doing well. She recently settled into RV living in Coburg and is kind of enjoying it. She continues to recover from her surgery, and learn new lifestyle changes.

Re: National Board of Trustee (BOT) Action on Life Membership Fees

National Board of Trustee (BOT) Action on Life Membership Fees

The National Board of Trustees met on 19 April 2023 to discuss the Marine Corps League's Life Membership Fees. It was determined that the Life Membership Fees have not been increased for approximately 19 years. In the year 2004, it was the last time that Life Membership Fees were increased at the National Convention. The National Board of Trustees has been discussing this increase for many years. The following paragraph is reprinted from the National Administrative Procedures:

"Section 7050. Life Members. ... Effective 1 September 2021 the Life Membership fee shall be as established by the National Board of Trustees and shall be posted on the National Website."

The National Board of Trustees has the fiduciary responsibility for the operation and budget requirements of the Marine Corps League. After full discussions and considerations, the National Board of Trustees voted and approved the following:

Effective 1 July 2023, the Life Membership Fees will increase as per the following chart:

\$1000.00 - 35 years of age and lower

\$800.00 - 36-50 years of age

\$600.00 - 51-64 years of age

\$ 400.00 - 65-84 years of age

\$100.00 - 85 years of age and higher

The above Fees are only available if the member's annual dues have been paid and the member is in good standing. Any member desiring to pay their Life Membership Fees at the current rate, must do so and be post-marked no later than 30 June 2023. Any Life Membership payments after that date are listed above.

Marines Help Put Down Prison Riot

On May 2, 1946, Marines from the Treasure Island Marine Barracks aided in suppressing a three-day prison riot at Alcatraz Federal Penitentiary in San Francisco Bay. The Marines were under the command of Warrant Officer Charles L. Buckner, a veteran of the Bougainville and Guam campaigns in World War II, and did not suffer a single casualty.

Marine Helicopter Comes Under Fire in Beirut, Lebanon

On May 5, 1983, a UH-1N helicopter carrying Colonel James Mead, the commander of the American peace-keeping force in Lebanon, was hit by machine gun fire in Beirut. Colonel Mead and his crew had just taken off in the helicopter to investigate artillery and rocket exchanges between Syrian-backed Druze militiamen and Christian Phalangists that was endangering French members of the multinational peace-keeping force when they came under fire.





Marines Help Evacuate New Orleans Flood Victims

On May 8, 1995, Marines from Marine Forces Reserve demonstrated the Corps' quick-response capabilities in helping evacuate more than 2,500 civilians from the New Orleans area after one of the most devastating storm in more than 200 years hit the region.

Marines March Toward Naha, Okinawa

On May 10, 1945, the 22nd Marines, 6th Marine Division, executed a predawn attack across the Asa River Estuary and captured a bridgehead that allowed them to continue their attack toward Naha, the capital of Okinawa.





John Mackie Becomes First Marine to Earn Medal of Honor

On May 15, 1862, Corporal John F. Mackie became the first Marine to earn the Medal of Honor for his Service on the USS Galena during actions against Confederate shore batteries at Drewry's Bluff, near Richmond, Virginia.

Marines Attack Half Moon Hill

On May 16, 1945, the 22nd and 29th Marines continued an attack against Half Moon Hill, a day that the 6th Marine Division would later describe as the "bitterest" of the entire Okinawa campaign. By May 18, the famed Japanese "Shuri line" was breached by American forces.





Marine Aviation Program Begins

On May 22, 1912, First Lieutenant Alfred A. Cunningham became the first Marine officer to be assigned to "duty in connection with aviation" by Major General Commandant William P. Biddle after reporting for aviation training at the Naval Aviation Camp at Annapolis, Maryland. This marked the official beginning of the Marine aviation program.

V-22 Osprey Makes its Debut

On May 23, 1988 the V-22 Osprey, the world's first production tilt-rotor aircraft, made its debut at Bell Helicopter Textron's Arlington, Texas, facility. More than 1,000 representatives from the military, the aviation industry, and the media gathered to hear various speakers, including then-Commandant of the Marine Corps, General Alfred Gray, praise the versatility of the aircraft.





Operation Pipestone Canyon

On May 26, 1969, Operation Pipestone Canyon began when the 1st Battalion, 26th Marines and 3rd Battalion, 5th Marines began sweeps in the "Dodge City"/Go Noi areas southwest of Da Nang, Vietnam. 610 enemy troops, as well as 34 Marines, were killed during the operation, which ended approximately one month later, in late June.

Operation Sea Angel

On May 29, 1991, elements of a joint task force that included the 5th Marine Expeditionary Brigade departed the South Asian nation of Bangladesh after nearly two weeks of disaster relief operations following Cyclone Marian, which resulted in more than 136,000 fatalities. The task force delivered relief supplies using helicopters, C-130s, and landing craft in *Operation Sea Angel*.

"Oregon continues to be a leader in recognizing, remembering and honoring the outstanding contributions of women who have served their country, and we are proud to be able to host this year's conference in person again," Fitzpatrick said. "Together, our collective voices achieve more, overcome challenges, and allow our stories to be shared."

Women veterans make up one of the fastest-growing segments of the Oregon veteran community, with an estimated 25,000 women veterans living in the state today, representing nearly one-tenth of overall veteran population.

The first Oregon Women Veterans Conference was held 25 years ago in 1998.

"The camaraderie and shared calling of service is what inspires our lives and is what continues to unite women veterans across every generation and era of service," said ODVA Women Veterans Coordinator Jessica Bradley.

The conference is an opportunity for women veterans to socialize, connect to resources, learn about their earned veteran benefits, and celebrate their service.

Notice to annual dues payers:

In accordance with National Headquarters rules, if an annual dues payer lapses past one year from the expiration date of the membership they will be dropped from the detachment's roster.

At this point there are two options, (1) the member can be re-installed by paying all back dues to include the current year; or (2) re-apply as a new member by completing a new application for membership.

If option number two is chosen, all previous membership service is eliminated and service time in the Marine Corps League begins anew.

Therefore, it behooves annual dues payers to keep their membership current. National Headquarters no longer places membership expiration dates on detachment rosters making it easy for a member to slip through the cracks.

The Detachment Adjutant has provided the Detachment Junior Vice-Commandant with a listing of Annual Dues Payers. If you have any question as to when your dues are coming up for Renewal, please feel free to contact him (contact information shown under Detachment Officers at end of Newsletter).

The next form should be completed and turned in by the 19 July 2023 monthly meeting. It has been requested that the forms be completed on a quarterly basis (April, May, June).

To facilitate the tracking, accounting, and reporting of Community Service Hours performed by Emerald Empire Detachment #917, Marine Corps League, members (Life/Regular/and Associate), we are asking each member to submit the following information.

Anytime a member performs Community Service Hours (Toys for Tots, Scouting, Young Marines, Funeral Honors, Parades, Assistance to Marines/ FMF Corpsmen / FMF Chaplains, Marines 4 Life, Rose Program, general assistance, etc.) we need to gather that information under the type of assistance or community service and the total number of hours performed for those tasks.

To simplify this task, we ask each member to track their own community service and the number of hours spent performing that service. This information will be collected, and tallied by the detachment so that at the end of the year we are able to submit the required information needed to complete the Detachment Annual Report. The easiest method of delivery would be to bring it with you to the monthly meeting. If unable to attend then the information can be submitted via email. Please submit only one monthly report and not a report for each activity each time performed.

The form that follows can be copied and printed for ease of tracking your hours. Then turn in at the monthly meeting (or mail).
